Central Hospital for Veterinary Medicine has an open position for a one-year avian and exotic animal specialty intern. Central is a VECCS Level 1 certified referral and emergency/critical care facility located in North Haven, Connecticut. The goal of the Avian and Exotic Animal Department is to provide high standard care for the avian and exotic patients in the local community. We are looking for a highly motivated, punctual, individual with excellent record keeping, and client care/communication skills.

The goal of the program is to provide further training in avian and exotic animal medicine in a busy, fast-paced private practice environment, with an emphasis on preparing the individual for a residency position. Primary day to day experience will include avian and exotic animal case management and work up of inpatients, assisting with appointments, primary emergency care, and hands-on experience performing basic and assisting with advanced procedures. Additional experience is gained through general hospital-wide teaching rounds and morbidity and mortality rounds, and departmental rounds. One in-house lecture is expected to be presented by the intern.

Aside from Dr. Shakeri of the Avian and Exotic Animal Department (board-certified in Avian Medicine and Surgery), the hospital is comprised of 3 board-certified internists, 2 board-certified cardiologists, 4 board-certified surgeons, 2 board-certified criticalists, 1 board-certified oncologist, 1 board-certified radiologist, 2 board-certified anesthesiologist, 1 board-certified behaviorist, 1 board-certified dermatologist, and 1 board-certified ophthalmologist.

Applicants must obtain a Connecticut state license (paid for by Central Hospital) prior to the start date of the program. Candidates will need to have completed a rotating internship in small animal medicine and surgery, and have a commitment to pursuing a residency within the avian and exotic animal medicine disciplines.

Benefits include paid licensure and liability insurance, paid health insurance, two weeks (80 hours) paid time off and four days (32 hours) of paid time for CE.

CHVM is located in North Haven, Connecticut, minutes from New Haven and Yale University. North Haven is located on the beautiful shoreline of Connecticut with open access to the Long Island Sound, hiking, skiing, and numerous outdoor activities. Several large concert venues are also nearby. New Haven County is home to pastoral countryside property, beachfront amenities, and centuries of rich New England history. We are located less than 1.5 hours from New York City, and approximately 3 hours from Boston.
